## **Standard Course**

### **Forklift Operator Training**

Thank you for your interest in our forklift operator training programs. Listed are the cost and a description of our **standard course**, which includes both classroom and hands-on instruction for up to 10 persons. The training will be conducted at your location and cover one or two classes of forklifts.

**Classroom Training:** Classroom training will include: Lecture, Films (s) and a written test. In accordance with OSHA requirements, site-specific topics and model specific topics will be addressed. Applicable fuels are covered such as Industrial batteries and chargers, Propane and liquid fuels. Hand-out booklets, and other pertinent printed material such as OSHA powered industrial truck regulations and fuel fact sheets are included.

**Hands-On Training** includes a demonstration of Pre-operation safety checks. An obstacle course will be devised that is intended to mimic your operation. I will demonstrate operation of a forklift thru the obstacle course. Individual hands-on Instruction and testing concludes the class. Operators who successfully complete the training, testing and evaluations will receive a certificate of completion.

**Duration:** approximately 6.5 hours, more or less depending on # of persons in a class and their past experiences operating a forklift.

**Cost\*** \$685.00 weekdays. \$785.00 Saturdays. Class size 1 - 10 operators.
